**Purpose:** The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HPE products to remove components and materials requiring selective treatment, as defined by Directive 2012/19/EU of the European Parliament and of the Council on Waste Electrical and Electronic Equipment (WEEE).

**1.0 Items Requiring Selective Treatment**

1.1 Items listed below are classified as requiring selective treatment.

## 3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. System Board Battery -- Remove the top cover and locate the battery on the system board. With a medium flat head screw driver remove the battery and dispose of properly.
2. System Megacell -- Remove the top cover and locate the megacell on the system board. Remove the megacell and dispose of properly.
3. Capacitors > 2.5CM -- Remove the power supply(s) from the system. With #2 Philips screw driver remove the screws securing the top cover and the heatsinks in the P/S then locate the capacitors and pry from the PCB with a medium flat head screw driver and dispose of properly.

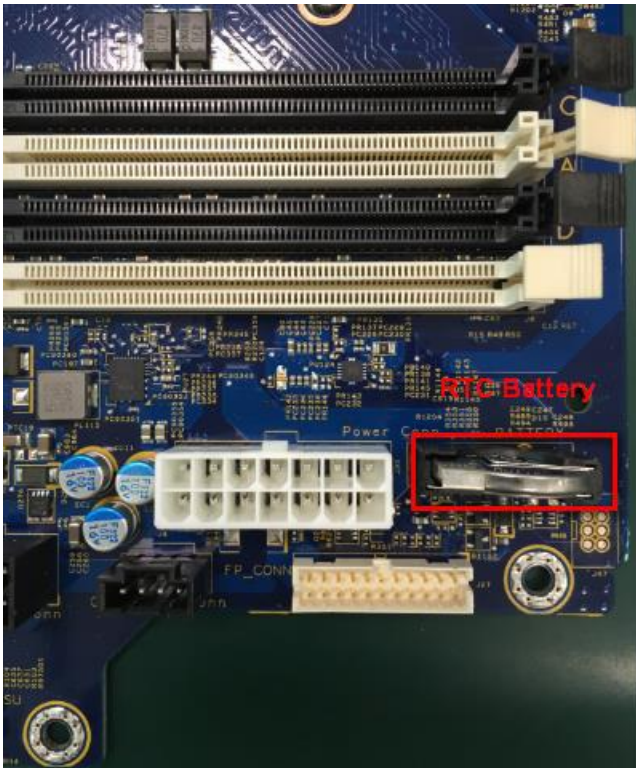
Attachment 1-- System battery location

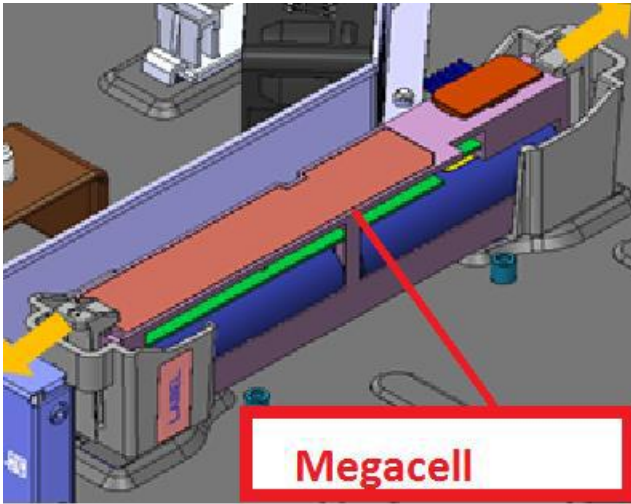

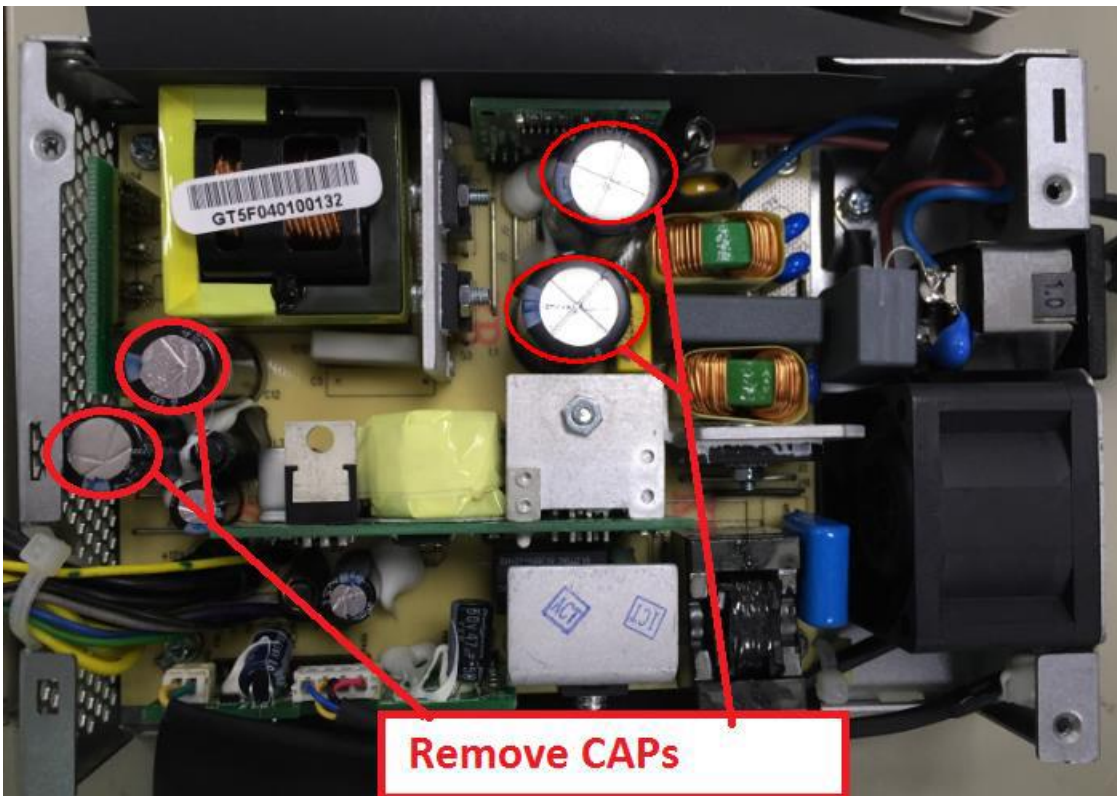
